***Tuition***

\_\_\_\_\_a. Tuition is due on the 1<sup>st</sup> of each month. Failure to pay by the 10<sup>th</sup> of the month will result in a late fee of \$10.00 which should be automatically added to your payment.

\_\_\_\_\_b. Any student whose tuition payment is more than 1 month late will be suspended from class until payment is received, then dropped from class after 60 days

\_\_\_\_\_c. **There are no partial tuition months.** Full tuition is due each month regardless of holidays, student illness, or absences. August tuition will be pro-rated. **September – May, FULL tuition**

\_\_\_\_\_d. There are no tuition refunds.

\_\_\_\_\_e. A written notice must be given 30 days prior to withdrawal of class.

\_\_\_\_\_a. Attendance is very important. If your child is absent more than two consecutive lessons, please notify The Dance Academy of the cause.
